


BRIEF TERMS & CONDITIONS

1. During the validity of the agreement the Hired Mid-Wife will be at liberty to terminate the agreement for betterment of his/her career or any other grounds by giving 7 days' notice to the Factory. The Factory can also terminate the agreement at any time during the tenure by giving 7 days' notice without assigning any reason what so ever. Agreement shall also be terminated, if the Hired Mid-Wife is found to be mentally or physically incapacitated or incapable of discharging his/her duties.



2. The Hired Mid-Wife shall undergo a medical examination at the Factory Hospital, before the contract is entered into, for his/her fitness to perform the work awarded to him/her.
3. Normally Sundays and National Holidays (Republic Day, Independence Day & Gandhi Jayanti) shall be off. If he/she is called for work on these days he/she will be granted off in lieu of that.
4. The Hired Mid-Wife will not be provided with any transport/transport arrangement. The hired Mid-Wife will not be entitled for any free medical treatment at Ordnance Factory Hospitals except First Aid in case of emergency.
5. The hired Mid-Wife shall attend to all the normal tasks which any Mid-Wife is conventionally doing including shift duties, escort duties to outstation. He/She will also attend emergencies/disasters and accidents.
6. The Hired Mid-Wife shall provide his/her services on Sundays/holidays once in a week and he/she will get off the next day as done/availed by regular Mid-Wife at station.
7. The General Manager/Ordnance Factory Badmal reserves the right to modify/alter/restrict/cancel the process due to any directives of Court/CAT case or as per instructions from Ordnance Factory Board/Ministry of Defence, without issuing any further notice or assigning any reason thereafter. The decision of GM/OFBL will be final and no appeal will be entertained against this issue.
